RING MILL S.p.A. is a leader in technology and product quality, with thirty years of experience in the production of forgings and rolled rings. It possesses the know-how necessary to handle a wide variety of metals: from the simplest carbon steel to sophisticated alloys used in the off-shore sector, in high-tech applications and in the conventional and nuclear energy fields.

The company's core business is the production of steel components derived from ingots and transformed to various stages of semi-finished and finished products through hot forming, heat treatment and finish-machining.

RING MILL S.p.A. works to the Customer's specifications and has the capacity to produce closed-die forgings from 200 to 1500 kg, rolled rings from 500 to 18000 kg, open-die forgings from 500 to 50000 kg and hollow-bore pieces up to 10500 mm in length.
